EVENTS & STAKES OFFERED:

Qualified Courser Test: Open to hounds at least 12 months of age. The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course. **Required for first time entry in the Open Stake.** QC forms are available for download at <http://www.akc.org/pdfs/IERSC6.pdf> or from the FTS.

Junior Courser Test: Open to hounds at least 12 months of age.

Open Stake: Open to any eligible hound that has obtained an AKC Qualified Courser certificate. **First time entries (FTE) in the Open Stake must submit an AKC Qualified Courser certificate with the entry.** This requirement will be waived for hounds that have earned a Field Championship title from ASFA or KKC. ASFA or KKC Field Champions must submit a copy of their title certificate to the host club when they enter their first AKC Open Stake. Championship points earned from the Open Stake will only count toward a Field Champion title. Hounds that have earned an AKC Field Championship title are not eligible to enter the Open Stake.

Open Veteran Stake: Open to all hounds which are eligible to enter Open or Special stakes and meet the age requirement for a veteran as established by the breed's parent club - 6 years of age; except Irish Wolfhounds = 5 years, Whippets = 7 years, Rhodesian Ridgebacks = 7 years, and Afghan Hounds = 7 years. Championship points will be awarded. Points won from the Veteran Stake may count toward either a Field Championship title or Lure Courser Excellent title.

Special: Open to all hounds that are eligible to enter the Open Stake and have earned their AKC Field Championship Title. No championship points are awarded from this stake.

Single: Open to all hounds of an eligible breed. Hounds are run by themselves, scored and placements are then determined on the basis of the score. All dogs that enter the Singles Stake compete against each other, regardless of breed. Results are not recorded to a dog's record and no title is earned. Hounds entered in Singles may not enter the regular stakes. Single winner is not eligible for BOB/BIF

Best In Field: shall be offered. All Best of Breed winners with **the exception** of Italian Greyhounds and FSS breeds shall be eligible to compete in the Best In Field competition.

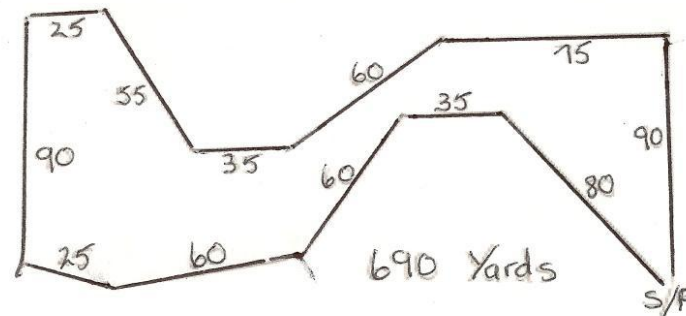
ELIGIBILITY and CONDITIONS OF ENTRY:

Hounds must be 1 year of age or older on the day of the trial. All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified. Bitches in season and lame hounds at roll call will be excused and their entry fee refunded. Hounds not present at roll call will be scratched after a five minute grace period. Battery powered, continuous loop lure machines will be used. The lure will consist of white plastic strips. The Trial will be run first, then the QC and JC Tests.
