



I understand that at the ASFA convention a ruling was passed that I.W.'s will have to be measured and meet the suggested minimum height as per the AKC Standard, or not be allowed to run.

I am violently opposed to such a ruling, since even the AKC has not seen fit to put in such a disqualification. Because of my opposition to this ruling I will not be running any of my dogs and neither do I feel that I should serve in any capacity at any ASFA lure course function.

The small number of people who were representing I.W. clubs and associations, who put this ruling through, did not to my knowledge take a poll of their respective memberships prior to putting through such a presumtuous rule. Perhaps this is what the majority of I.W. owners would want, but I think that they should have at least been given the opportunity to vote on such an important subject.

The reason given for this rule, I understand, was that small I.W.'s are being bred to win at lure coursing. As anyone who has ever bred a litter of I.W.'s should know, small ones are not in demand. I'm sure that such a breeding program would soon die from lack of buyers. There are not enough lure coursers in the world to destroy the #1 demand in I.W.'s, which is great size (and often less quality).

I might add that due to the longer stride, I found my tall, lean I.W. much faster than my smaller one.

New Ruling on Dogs May Be Too Broad

A CAN OF WORMS may have been opened by the Fish and Game Commission when it set new regulations prohibiting the "pursuing of all wildlife" by dogs in a large part of the state.

A Department of Fish and Game release states: "In its move to add more protection for bears, the commission outlawed the use of dogs for pursuing wildlife from April 1 through August 31 in the early bear hunting season and from April 1 through August 31 in the late season area.

The new regulation for dogs does not affect dog training and field trials, dogs on licensed pheasant effuls, the use of dogs by persons authorised to take predators and pursue mountain lions.

"Present regulations outlay the use of dogs in the pursuit of bear except during bear husting seasons. Pursuit of some wildlife species is allowed, although wardens say enforcement of rules protecting other amimals is difficult."

In my opinion, the regulation is too broad and impossible to enforce. Where do you draw the line?

Brittany spaniels have been known to go to the base of a tree where they've seen a squirrel. If I allow them they will sit there for hours, even though in ten years they have never caught a squirrel is this pursuit or semi-pursuit? Do I need a permit?

I take my dogs fishing. This is a dull sport for dogs so they've taken up the hobby themselves. They will spot pollywogs or minnows in the shallows and try for hours to catch them. They have never caught anything but they are definitely trying. Is this now illegal wildlife pursuit, semi-pursuit or has it always been illegal?

What about the harrier? This is the most ancient form of hunting where hounds like greyhounds and whippets pursue game such as coyote or fox or rabbits. These guys definitely would need a permit.

I think the burden of enforcement will be placed on the game warden in the field. But there are wardens and there are wardens.

THE COMMISSION is probably trying to kill an ant with a sledge hammer again. The whole idea of the new regulation was to give the warden some ground to stand on when he caught the very few guys who ever misuse their hounds, especially during the short period when the sows have very young cubs.

In the past, guilty hunters could say they were only after rabbit or coyote. Even when the warden was absolutely certain of what they were actually doing, he couldn't do much.

I know the type of outdoorsmen who go for hound hunting in the first place. The responsible ones never have pursued bear in the wrong way or at the wrong time. For the ones that do, the new regulations will merely and spice to an illegal game.

R for Fido, Fifi and Friends

As any urban dweller knows, the U.S. is quite literally going to the dogs —to say nothing of cats, canaries, parakeets, turtles and, indeed, a whole Noah's ark of creatures. Accompanying the pet population explosion is the spectacular growth of medical care dedicated solely to Fido, Fifi, Polly and friends. There are now 30,000 doctors of veterinary medicine in the U.S., and the number is rising. In addition, there are more than 1.000 U.S. and Canadian animal hospitals. These range from small storefront one-doctor facilities to such gleaming temples of animal care as the ninestory Animal Medical Center on New York's East Side, an edifice that has operating rooms, pharmacies, research labs and a 24-hour emergency room.

Nowhere has this heightened interest in animal medicine been more emphatically displayed than at the annual meeting of the American Animal Hospital Association (A.A.H.A.), which attracted some 2,500 vets from the U.S. and 15 other countries to Boston this year. The conventioneers were shown everything from daily birth control pills for fecund bitches and orthopedic braces for dachshunds (whose elongated proportions make them prone to backaches) to monster gas-filled balloons that can deliver anesthetics during surgery on horses. Still, the greatest interest was stirred by the plethora of scientific papers underscoring a little-known facet of the pet craze: for all their infatuation with the animal kingdom, Americans all too often mistreat their pets—frequently out of misguided kindness.

Like their masters, many pets are too fat for their own good. The reason, explained San Antonio Vet Oscar Woytek, is that Americans tend to feed their animals, especially dogs, the same high-quality, cooked table meats with which they gorge themselves. That not only adds beastly pounds, but hurts the animal in other ways. A German shepherd, for instance, can exert so much pressure with his jaws (700 lbs. per sq. in.) that he can easily splinter a cooked bone into tiny shrapnel-like pieces, some of which may perforate his intestines. It is far better, says A.A.H.A. President Warren Walker, to give dogs uncooked shank or knuckle bones, which are harder and less likely to fragment.

Root Canals. Teeth are also often neglected. Milwaukee Vet Ray Pahle pointed out that he regularly removes tartar buildup from canine choppers. caps those that have worn down and has even done costly root canal work on abscessed teeth. Pahle also suggested an easy remedy for animal bad breath: brush the offender's teeth daily-if he allows it. Other vets noted the growth of a more serious problem: heartworm—a mosquito-borne parasite that lodges in the heart, can reach a foot in length and blocks the oxygen supplied to the body. Eventually the dog tires after the slightest exertion. Several drugs are now available to prevent and treat this spreading canine disease.

Some pet problems can be handled with the oldest of remedies: loving care and companionship. In many cases, Topeka Animal Dermatologist George Doering reported, dogs resort to tail-chewing as a ploy to get attention from a neglectful master. Doering's prescription: either devote more time to the pet or, if Rover is willing, bring in another dog as a playmate.

I look forward to the fine jub 1 know she will do. We, however, can help Paula tremendously by sending articles and suggestions to the new home base for the bulletin:




