SINGLES STAKE:. Open to all hounds, including those disqualified to run in other stakes.

BEST IN FIELD WILL BE OFFERED

- *All hounds will run twice, in trios if possible or braces unless excused, dismissed, or disqualified.
- *Hounds not present at the time of roll call will be scratched after a 5-minute grace period.
- * Each entry will be examined at inspection for breed disqualifications. Bitches in season and lame hounds will be excused.
- * Entry fees for hounds excused during inspection for bitches in season, lameness, or disqualifications will be refunded.


