There are three types of membership open to all persons sixteen years of age or older who are in good standing with The American Kennel Club and who subscribe to the purpose of the NCIWC Non-Profit Corporation.

Associate Membership: Non-voting member of the Club who cannot hold office or be counted in a quorum. Receives one copy of the Club's publication: The Hounds' Bugle. **One club member-sponsor required.** Annual dues: \$35.00

Single Active Membership: Voting member of the Club. Receives one copy of the Club's publication, The Hounds' Bugle. One year Associate Membership required before eligibility for Single or Active Membership. **Two non-related active member sponsors required.** Annual dues: \$35.00

Family Active Membership: Same as Single Active Membership except two voting members of the Club sharing the same household. **Two non-related active member sponsors required.** Annual dues: \$45.00

For any application for membership that is approved after January 1, the dues payable shall be reduced by 50% for current year only.
